2023 Volunteer Service Agreement

It is mandatory for parents/guardians to volunteer in some capacity for the league, as this is a completely parent-run organization with no paid positions. Please see the Volunteer Service Requirement in the Membership Information for more details on year-round service opportunities.

Home games require an all-hands-on-deck approach to make them work. **At least 1 adult member per participating skater is REQUIRED to assist at all home games** when your skater is participating.

At least one adult member for each skater MUST be trained on at least 2 Non-Skating Official (NSO) positions and MUST sign up for an NSO position at each home game when your skater is participating. Signing up for an NSO position is required because filling all NSO slots is necessary for the game to occur.

If there is more than one participating skater in your household, 2 adult members are required to assist. In addition to parents and guardians, adult siblings (over 18) and other close relatives can serve as adult members and can be trained in NSO positions to work home games.

I understand that I and/or another adult member are required to learn at least 2 NSO positions and volunteer to serve as an NSO for all home games in which my skater is participating. I also understand that not fulfilling the volunteer requirements may cause my skater to be ineligible to be rostered for future games.

2023 Skater Code of Conduct

1. I will lead by example and demonstrate good sportsmanship with fellow skaters, coaches, officials, parents, and other attendees at every game and practice.
2. I will attend every practice and game, and I will notify my local league coach or JRDA representative via phone, email, or Facebook message if I will be absent. I will be on time for practice and games.
3. I will listen and learn from my coaches and other league members.
4. I will treat my coaches, other league members, officials, and fans with respect regardless of race, gender, creed, or abilities, and I will expect to be treated accordingly.
5. I deserve to have fun during my sports experience and will tell parents or coaches if it stops being fun!
6. I deserve to play in an environment that is safe and free of drugs, alcohol, and tobacco. I will not use drugs, alcohol, or tobacco, and will expect adults to refrain from their use at all youth sports events.
7. I recognize the importance of school and will not allow my derby commitment to interfere with my academic success.
8. I will learn the rules of the game of Roller Derby, according to the most current JRDA standards.
9. I will not engage in any behavior which would endanger the health, safety, or well-being of coaches, parents, league members, officials, or any other attendees.
10. I will not engage in the use of profanity, verbal or physical threats, or any abuse aimed at coaches, parents, league members, officials, or any other attendees.
11. I will not perform, on or off the track, any activity which I feel may endanger my health and safety, and will report any pressure to perform such activities to a member of the League leadership.

If I fail to abide by the above code of conduct, I will be subject to disciplinary action that could include but is not limited to the following:

- Verbal warning by a JRDA official or coach, and/or head of league organization
- Written warning
- Expulsion from a game
- Multiple-game suspension
- Player Probation
- Player season suspension

2023 Parent Code of Conduct

1. I will not force my child to participate in Junior Roller Derby
2. I will promote the emotional and physical well-being of the skaters ahead of any personal desire I may have for my child to win.
3. I will inform the coach of any physical disability, injury, or illness that may affect the safety of my child or the safety of others.
4. I (and my guests) will not engage in any kind of unsportsmanlike conduct with any official, coach, skater, or parent such as booing and taunting: refusing to shake hands: or using profane language or gestures.
5. I will respect the officials of their authority during games and will never question, discuss, or confront coaches or officials at the rink, and will take time to speak with coaches at an agreed-upon time and place.
6. I will encourage my child to play by the rules and to resolve conflicts without resorting to hostility or violence.
7. I will encourage my child to treat other players, coaches, officials, and spectators with respect regardless of race, religion, color, gender, gender identity, sexual orientation, or ability.
8. I will encourage a safe sports environment for my child that is free from drugs, tobacco, and alcohol. I will refrain from using drugs, alcohol, or tobacco at any youth sporting event.
9. I will refrain from coaching my skater or other players during games and practices, unless I am one of the official coaches for and registered with a JRDA league and coaching the whole team.

If I fail to abide by the above code of conduct, I will be subject to disciplinary action that could include but is not limited to the following:

- Verbal warning by a game official, JRDA Representative, or local League Board Member
- Removal from the track or spectator area
- Penalties served by my team if my behavior creates an unfair situation on the track
- Parental game suspension
- Parental season dismissal

2023 Hold Harmless Agreement

RELEASE AND WAIVER OF LIABILITY

ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

Together with my parent or guardian, represent, covenant, and agree, on behalf of myself and my heirs, assigns, and any other person claiming by, under, or through me, as follows:

I acknowledge that roller skating and the sport of junior roller derby are inherently dangerous activities, but still desire to participate in these activities at my own risk. If a parent or guardian of a minor, the undersigned agrees to allow the minor named below to participate in these activities at their own risk.

I am further aware that the usual risks, hazards and dangers (hereafter "risks") of personal injury, death, disability, property damage and other loss, necessarily increased when wearing roller skates and playing junior roller derby. These risks include but are not limited to falling, jumping, landing, skaters getting in front of you, skaters leaning on you, tripping over the fallen skaters, performing tricks, "showboating," and colliding with others such as staff, media personnel, and spectators. These risks may vary from time to time and day to day based on the skater's own fatigue (tiredness), equipment, and other factors.

For valuable consideration, including permission to skate with the junior derby in any way, including but not limited to being permitted to compete, officiate, observe, or participate in any other way, I hereby release, waive, discharge, and covenant, not to sue the Indianapolis Junior Roller Derby League, the National Junior Roller Derby Association, Circle City Derby Girls, Race City Rebels, Indy Parks and Recreation/City of Indianapolis, visiting or hosting roller derby leagues, owners of practice venues or other skate venues, agents, subsidiaries, employees, volunteers, or any other person or entity in any way associated with the Indianapolis Junior Roller Derby League (all hereinafter collectively referred to as "Releasees") from liability, to the undersigned, his/her personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned arising out of or related to use of any and all game venues or any place the junior derby might be having an event or other activities, I hold harmless its premises, or equipment, whether caused by any act of negligence of the Releasees or otherwise.

I hereby **assume full responsibility** for any risk of bodily injury, death or property damage arising out of or related to the use of the practice space, game venue, or any other properties, its premises, or equipment, whether caused by any act of negligence of Releasees or otherwise.

I hereby agree to indemnify, save, and hold harmless the released from any loss, liability, damage, or cost they may incur arising out of or related to use of the practice space, game venue or any other properties, it premises, or equipment, whether caused by any act of negligence of the Releasees or otherwise.

I further agree that this release is intended to be as broad and inclusive as possible.

I understand that participants are required to wear an adequate helmet, wrist guards, elbow pads, knee pads, and mouth guards while participating. Participants are required to follow all rules of conduct and are not to take unreasonable risks while using the practice space and playing junior roller derby, including causing other skaters to be at unreasonable risk of harm.

I have completely read and understand this waiver and release and its terms.

I understand that I have given up substantial rights by signing it, and I have signed it freely and voluntarily without any inducement, assurance, or guarantee being made to me. Prior to signing this waiver and release, I have had the opportunity to ask any questions about the waiver and release of Indianapolis Junior Roller Derby.

Volunteer Assumption of Risk

By volunteering for the Indianapolis Junior Roller Derby, I understand that roller derby is an inherently dangerous sport and my risk of injury has increased merely by being a volunteer. I am further aware that the usual risks, hazards, and dangers of personal injury, death, disability, property damage, and other loss have also increased. Although, I am not skating I understand that the risk of a skater running into me and falling on top of me is the nature of the sport, and I hereby release, waive, discharge, and covenant, not to sue Indianapolis Junior Roller Derby, Circle City Derby Girls, Indy Parks and Recreation/the City of Indianapolis, or any other venue or practice space I may be volunteering at for any injury sustained, property damaged, or any other loss I may sustain due to volunteering for IJRD.

IJRD will run mandatory limited background checks on all volunteers that have direct regular contact with skaters (coaching/training staff and referees), to ensure the safety of our youth skaters. **You are prohibited from volunteering for this organization if you have been convicted of any type of crime against a child.** If you are found to have a felony of this type on your record, you will be promptly dismissed. It is the responsibility of IJRD to keep and uphold a secure and safe environment for children.

Volunteers for IJRD do not get paid any monies for their volunteerism. IJRD reserves the right to dismiss a volunteer for any reason they see fit without notice, including but not limited to; behavior exhibited that may be deemed as harmful to the league, its representatives, members, or sponsors will be dismissed.

By signing this agreement I grant IJRD permission to run a background check and understand that I am volunteering at my own risk.
